



MOU Between

This Agreement is made between **Iran Polymer and Petrochemical Institute** headquarters at Tehran, Km 15, Tehran-Karaj Highway, Pajouhesh Science Park and Postal code: 1497713115, P.O. Box: 14965\115, Tehran-Iran, I. R. Iran (Hereinafter called **IPPI**) and **UCAPLAST**, **Union des syndicats des PME du Caoutchouc et de la Plasturgie**, 39 rue de Pommard - 75012 PARIS-France (Hereinafter called **UCAPLAST**)

The Parties have agreed as follows:

- 1- Providing facilities for short and long term visit of academic staffs, graduate and post graduate students.
- 2- Presenting short or medium joint time training courses or workshops in different aspect of polymer science and engineering for academic staffs, graduate students, experts, scholars and industrial units under the business incubator.
- 3- **IPPI** and **UCAPLAST** will work together to identify opportunities for research collaboration and shall form the basis for the parties to execute joint research work in the area of polymer science.
 - Other areas of collaboration may be added by the Parties' mutual consent in writing.
- 4- **IPPI** and **UCAPLAST** will provide consultation and advice on technical matters concerning research work carried out jointly or independently by the either parties.
- 5- Training Iranian coach by sending experts of IPPI for technical courses in order to improve the level of technical knowledge.
- 6- Exchange technical knowledge and information in the field of attracting investors and entrepreneurs in related fields.







- 7- Cooperation in the field of development of Iranian products in terms of quantity, quality and technology aimed at the Iranian market and the market of neighboring countries.
- 8- Manner of implementation for the agreement
- 8.1. The parties shall designate one representative with equal representation for coordination.

Mehdi Nekoomanesh, Director of IPPI is considered as **IPPI** representative and Denis Vaillant, Président of UCAPLAST is considered as representative.

- 8.2. The representatives shall be responsible for the following:
 - 8.2.1. Preparation of technical and commercial proposals for research and development projects.
 - 8.2.2. Exchange of available information and confidential information not constituting trade secrets concerning the research and development projects and technical training programs planned, in progress, or completed by the respective party.
 - 8.2.3. Exchange of available information on specific items of mutual interest to the parties.
- 9. IPPI and UCAPLAST will each be responsible for their own costs incurred in the development and preparation of any research and technical training agreement, proposal, technical visit and exchange of data and samples arising from this agreement, unless otherwise agreed to in writing.
- 10. All intellectual property used in connection with any collaborative activity shall remain the property of the party creating such intellectual property. Any intellectual property discovered, made or conceived in the further development of and/or performance of any collaborative activity shall be determined by the terms of specific research agreements negotiated by the parties. The parties will endeavor to reach an agreement regarding intellectual property rights prior to the creation of the intellectual property.
- 11. Duration of this agreement.
- 11.1- This collaboration agreement shall be effective for a period of 5 years from date of execution and maybe extended by the mutual agreement of the parties.
- 11.2- Neither party shall be liable to the other party for any claims for loss of anticipated profits or damages for, on account of or arising from termination of this agreement.





- 12. Amendments
- 12.1. This agreement may not be amended except by a written instrument signed by the parties hereto or their authorized representatives.
- 13. Governing law of this agreement.

This agreement shall be governed and construed in accordance with international norms.

- 14. IPPI and UCAPLAST agreed with Pars Marlik Aria co. as a coordinator and executive party.
